16. REGULATION on the payment of assistance by the employer

Based on Article 19, paragraph (1) of the Law on the Government of the Federation of Bosnia and Herzegovina ("Official Gazette of the Federation of Bosnia and Herzegovina", no. 58/02, 19/03, 2/06 and 8/06), the Government of the Federation of Bosnia and Herzegovina, at the 22nd session, held on 12/12/2023. year, brings

REGULATION

ON THE PAYMENT OF ASSISTANCE BY THE EMPLOYER

Article 1 (Subject of the Regulation)

This regulation regulates the right to the payment of assistance by the employer, the dynamics of the payment and the method of realization.

Article 2. (Persons exercising the right to assistance)

(1) The right to assistance, due to the inflationary increase in prices, has a person who has an established employment relationship with the employer in accordance with Article 4 of the Law ("Official Gazette of the Federation of Bosnia and Herzegovina", no. 26/16, 89/18 and 44/22).

(2) The right from paragraph (1) of this article is available to persons found in an employment relationship on the day of payment of the monetary amount.

Article 3 (Amount of assistance)

(1) The employer may, on the basis of this regulation, pay assistance in a maximum amount of up to 2,520 KM (two thousand five hundred and twenty convertible marks).

(2) The employer can pay the assistance in an amount that is smaller than the amount from paragraph (1) of this article.

(3) The assistance referred to in paragraph (1) of this article can be paid in the period from the date of entry into force of this regulation, and no later than the date of termination of this regulation.

(4) Payment of aid from paragraph (1) of this article will be made exclusively to the employee's transaction accounts.

(5) Assistance from this article is not considered a salary or salary compensation according to the provisions of the Labor Law ("Official Gazette of the Federation of Bosnia and Herzegovina", no. 26/16, 89/18 and 44/22).

Article 4 (Dynamics of payment)

(1) Payment of aid can be made in up to six tranches (parts), with the total amount not exceeding the amount from Article 3 of this regulation.

(2) The aid can also be paid in a one-time installment.

Article 5 (Prohibition of discrimination)

Payment of assistance is made to all employees who are found in employment on the day of payment of assistance, without discrimination in any way.

Article 6 (Basis for payment of allowance)

The employer is obliged to adopt an internal act (e.g. decision, rulebook) which will regulate, among other things, the amount of assistance, the date of payment, the number of installments and the conditions of payment.

Article 7 (Individual Acts)

Individual acts, which are adopted by the employer to exercise the rights from Article 2 of this regulation, must be adopted in writing.

Article 8
(Entry into force and termination of validity)

This decree enters into force on the following day from the date of publication in the "Official Gazette of the Federation of BiH", and ceases to be valid on June 30, 2024. years.
